1. <u>Purpose</u>: Pre Trial Notification is to obtain the willingness and commitment from the invited players for trials with a view of selecting players (Men's/Women's) to represent Sri Lanka National team at 21st Asian Squash Team Championship 2022 to be conducted as per the dates mentioned in para 2 and also as per the notice given by Asian Squash Federation.

3. **Number of Entries:**

Each team is entitled to a maximum of 4 players

4. <u>Selection Criteria</u>: Based on followings;

- a. Selection of the players will be executed in line with Sri Lanka Squash, selection criteria for participation in International tournaments. The following points will be considered for eligibility;
 - i. Availability of Points in latest ranking list as at 1st May 2022 (Weightage on Men's / Women's Open Category)
 - ii. Analyzing the past performance of tournaments conducted in 2020-2022
 - iii. Current form of particular player as per SLS records
 - iv. Participation and performance during the selection trials in year 2021/22
 - iv. Performance shown during international tournaments in year 2021/22
 - vi. Any international ranking
- b. Seeding will be done by considering the latest ranking list as at 1st May 2022 and also mainly focusing on the current form of particular player by analyzing past performance of tournaments conducted in 2021/22, selection trials and performance shown during international tournaments in year 2021/22.

iv. S/By Venue - Air Force Squash Complex, Ratmalana

7. The guidelines and instruction to be followed;

- a. All eligible players in para 5.a, willingness to be submitted on or before 12.00 pm SLS time, 8th August 2022 by email to Sri Lanka Squash squashsrilanka@yahoo.com and copying to eranga88alwis@gmail.com and erandagee@yahoo.com. Please note that non submission of willingness on or before due date is considered as unwilling to participate for the trails, and would not be considered further.
- b. Maximum number of 12 players from each Men's/ Women's are called for the trials. Two Squad of respective categories (Men's/ Women's) will be decided upon the final receipt of the willingness for trials and maximum players for the final trial squad will be maximum 6/7 players.
- c. Tentative schedule dates will be subjected to change due to unavoidable events or circumstances. However, final trial notification will be circulated before 14 days of commencing the trial as per para 6.a
- d. It will be mandatory for the players selected for the final team to attend for the practice sessions arranged by SLS until completion of the said championship.
- e. Standard SLS point system will be followed.

- f. Matches will be played according to the Round Robin system follows.
- g. Please note that a player needs to play a minimum 2 selection trial matches per day.
- h. Single Referee system will be followed.
- i. No postponement of matches will be allowed
- j. Players are required to be present 30 minutes before the scheduled time of the match.
- 9. It is requested to note that the financial assistant <u>will not be guaranteed</u> by Ministry of Sports / SLS for above tournaments and players will have to secure sponsorships if financial assistance could not be obtained from Ministry of sports for same.
- 10. Team order and related decisions will be taken by the team manager/coach appointed by SLS in line with ASF guidelines and best interest of Sri Lanka Squash.
