- b. Top four (4) players will be selected as finalists according to the condition mentioned in Para 4.
- c. Seeding was done considering all the results of the above mentioned performance.

a. Dates - 1st to 3rd December 2022

b. Time - Weekends/ Holiday : 8AM to 6PM

Weekday : 3PM to 7PM

c. Venue - SSC, Colombo 7

d. Stand by venue- Air Force Squash Court Complex, Ratmalana

9. The guidelines and instruction to be followed;

- a. Standard SLS point system will be followed. (Attached to this email)
- Note: SLS Point system is published in the Sri Lanka Squash official Web site https://srilankasquash.lk/sri-lanka-squash-slsselection-criteria-for-participation-in-international-tournaments/
- b. Matches will be played according to the Round Robin system follows
- c. **All players** should be report to Venue (SSC, Colombo 7) at 3 PM hrs on 1st December 2022 for the draw/respective initial matches.
- d. Please note that player needs to play 2/3 trails matches per day.
- e. Single Referee system will be followed.
- f. No postponement of matches will be allowed.
- g. Players are required to be present 30 minutes before the scheduled time of the match.
- j. Any dispute/observation/complaint pertaining to the draw, matched played etc (within 2 hours from the incident) should be forwarded in writing to the Chairman Tournament Committee (mobile no. 0714164236 / 0772229343).
- k. On completion of the final trails, 04 players will be selected from Girls/ Boys team as per the final point table.
- 10. It will be mandatory for the players selected for the final team to attend for the practice sessions arranged by SLS until completion of the said championship. As such, all players are required to provide written consent before commencing the trials on 5th December 2022, stating willingness to attend for the pool practices until completion of the championships.

11. **Tour Funding** –

- a. It is hereby stated that the financial assistant **is not guaranteed** by Ministry of Sports / SLS for tour and players will have to secure sponsorships if financial assistance could not be obtained from Ministry of sports for same.
- **b.** All trial participating player's parent/ guardian are required to provide a written statement before commencement of the trial regarding the possibility and willingness to securing sponsorship on players own in the case of financial assistance for the tour will be denied by the Ministry of Sports. SLS will support and work with the player in providing any support in documentation regarding this.
- c. Kindly note that individual cost for player is **approximately Rs. 300,000**/ (Entry Fees, Visa and Air ticket, Food & Accommodation) at current estimates.
- 12. Team order and related decisions will be taken by the team manager/coach appointed by SLS in line with ASF guidelines and best interest of Sri Lanka Squash.
